

## Code of Conduct for Swimmers.

Fin2Fit sessions should offer a positive experience for swimmers where they can learn new things in a safe and positive environment. Failure to comply with this Fin2Fit Swimmer code of conduct may result in your session being cancelled or cut short.

As a swimmer enrolled onto any Fin2Fit programme, party or experience, you are expected to abide by the following code of practice:

### Fin2Fit Swimmers are expected to:

1. Provide accurate and truthful information at the time of enrolment.
2. Update the Fin2Fit teacher of any changes in relevant medical information prior to your session.
3. Be friendly and welcoming to new members.
4. Contribute to making your session a fun place to be.
5. Be supportive to other Fin2Fit swimmers and offer comfort when required.
6. Respect Fin2Fit teachers, play fairly and accept decisions.
7. Show good sportsmanship and team spirit.
8. Keep within the Fin2Fit session area.
9. Take care of all equipment owned by the session teacher.
10. Keep to agreed timings for sessions and inform the Fin2Fit teacher if you are going to be late.
11. Respect the site specific Fin2Fit session rules.
12. Keep yourself safe during sessions and follow the instruction of the Fin2Fit Teachers at all times.
13. Refrain from rough and dangerous play.
14. Report any unsafe, risky or inappropriate behaviour within Fin2Fit sessions to the Fin2Fit teacher.
15. Wear suitable and well fitting swimming kit.
16. Pay any fees for sessions or events prior to taking part.
17. Not instigate or get involved in peer pressure or push others into something they do not want to do.
18. Not cheat, be violent or aggressive to any other Fin2Fit swimmer or Fin2Fit teacher.
19. Refrain from the use of bad language or racial/sectarian references. This includes bullying using new technologies like social media or messaging.
20. Not smoke at sessions or whilst representing Fin2Fit, including when wearing Fin2Fit kit.
21. Not consume alcohol or drugs of any kind at sessions or whilst representing Fin2Fit, including when wearing any Fin2Fit kit.
22. Respect the rights, dignity and worth of all participants regardless of age, gender, ability, race, cultural background or religious beliefs or sexual identity.
23. Refrain from session photography unless approved prior to the session by the Fin2Fit teacher.

\*Please note that this list is not exhaustive and can be reviewed/adjusted at any time by the Triton Training and Fin2Fit directors.

\*\*Triton Training and Fin2Fit policies must be adhered to at all times.
