Swim England Qualifications (Previously ASA)

To become a fully qualified Swim England swimming teacher, there are two qualifications required. The Swim England Level 1 Swimming Assistant (Teaching) course is the first step, which allows you to support a Level 2 qualified swimming teacher. We then recommend gaining at least three months' experience as a swimming assistant before progressing onto a Level 2 Teaching Swimming course (although this is not always a necessity). Once you have achieved your Level 2 qualification, you can add to your skills to specialise in specific areas of swimming teaching, such as parent and toddler lessons.



Safety Training Awards (STA)

The first step you'll need to take to become a fully qualified swimming teacher with STA is the Award qualification. The STA Award will develop your vocational skills and technical knowledge, so you can independently teach your own class of 12 participants from non-swimmers, beginners or improvers (children and adults). The next step to progress as a swimming teacher is to retain your swimmers by offering advanced lessons, extended skills and advanced awards with the STA Certificate.



Fin2Fit Mermaid Instructor

This one-day Swim England accredited CPD qualifies you to take mermaid lessons, complete with mono-fins and mermaid tails. Must hold a swimming teachers qualification and current DBS certificate as a prerequisite





WHAT WE WOULD NEED FROM YOU

Below we detail the minimum space we need for each of the qualifications. We would also need your swimming lesson programme beforehand, or pool space and contact details to arrange additional lessons. For you, we can offer free spaces for your staff, or we can discuss hire fees for the courses.



Swim England Level 1

- Classroom space for 16 learners for up to 16 hours (with tables and chairs).
- Pool space for practical with the learners for 2 hours (at least 2 lanes).
- All candidates need to be able to assist 4 lessons with the main teacher teaching, they will take the warm up/ cool down.



Swim England Level 2

- Classroom space for 12 learners for up to 40 hours
- Pool space for practical with the learners for 8 hours (at least 2 lanes).
- All candidates need to teach 6 lessons to Stages 1-7, with at least 4 swimmers per lesson.



- Classroom space for 12 learners for 25 hours
- Pool space for practical with the learners for 3 hours (at least 2 lanes)
- All candidates need to teach 5.5 lessons to non-swimmers, beginners, improvers and advanced (Stages 1-7) to 4 swimmers



STA Level 2 Certificate in Teaching Swimming

- Classroom space for 12 learners for 20 hours
- Pool space for practical with the learners for 3 hours (at least 2 lanes)
- All candidates need to teach 5 lessons to advanced swimmers (Stages 5-10) to 4 swimmers



Fin2Fit

- Classroom space for 12 learners for 7 hours (with tables and chairs)
- Pool space for practical with the learners for 2 hours (at least 4 lanes)
- All candidates need to teach 1 lesson with the fins on.

ADDED VALUE TO YOUR CENTRE

All candidates on swimming teacher courses need to be assessed practically, this means they will need to teach within swim school lessons.

This can either be in lessons that are currently running in your own swim school, in partnership with swim schools who hire your pool or we can help you add value to your pool programme by adding short term crash courses to your programme.

No matter which option you choose we are able to facilitate the logistics with no disruption or additional workload to yourselves. We can discuss what method would be best to meet the requirements of the course and to benefit your centre the most.
